

### Work Experience

I retired from the Naval Surface Warfare Center, Dahlgren in 1994 after nearly 30 years of service as a supervisory Mathematician. Most of my career, I did software quality assurance work. I headed two branches during that time, also. I had some experience as a system engineer and program manager. After retirement, I worked part time at Mary Washington Hospital for approximately two years as a monitor technician. In that job I was responsible for monitoring and interpreting patient heart monitors. After volunteering for several years at the Lloyd F. Moss Free Clinic (see details below), I worked part time there for approximately two years. During that time I coordinated their primary clinic on Tuesday and Thursday evenings. Currently I am not working.

### Volunteer Experience

I am a life member of the Brooke Volunteer Fire Department. During my 38 years as a member, I have fought fires, ran emergency medical calls, and served in several leadership positions, both administrative and operational. I no longer actively run calls, but I am currently a member of the Board of Directors. During my service I have taken many fire fighter classes as well as emergency medical service (EMS) classes. I still am certified in the state of Virginia as a paramedic. As mentioned above, I volunteered for several years at the Lloyd F. Moss Free

Clinic. There I acted as a medical screener and medical technician. I was responsible for obtaining vital signs, giving inoculations, maintaining emergency equipment, administering EKGs, teaching patients to use newly issued equipment, and other medical procedures. I was the fire and EMS representative on the Stafford County Transportation Safety Commission for several years. I volunteered at the George Washington Birthplace National Monument for approximately three years where I assisted the rangers with re-cataloging and digitizing their artifact records. I volunteered briefly at Ferry Farm washing artifacts. I am an active member of the Andrew Chapel United Methodist Church where I currently sing in the choir.
