# BOARD OF SUPERVISORS STAFFORD, VIRGINIA DRAFT MINUTES

Regular Meeting

May 2, 2017

<u>Call to Order</u> A regular meeting of the Stafford County Board of Supervisors was called to order by Paul V. Milde, III, Chairman, at 3:00 p.m., on Tuesday, May 2, 2017, in the Board Chambers, at the George L. Gordon, Jr., Government Center, 1300 Courthouse Road, Stafford, VA.

<u>Roll Call</u> The following members were present: Paul V. Milde, III, Chairman; Meg Bohmke, Vice Chairman; Jack R. Cavalier; Wendy E. Maurer; Laura A. Sellers; Gary F. Snellings, and Robert "Bob" Thomas, Jr.

Also in attendance were: Thomas C. Foley, County Administrator; Charles Shumate, County Attorney; Marcia C. Hollenberger, Chief Deputy Clerk; Cheryl D. Giles, Deputy Clerk; associated staff and other interested parties.

School Superintendent, Dr. Bruce Benson, addressed the Board and talked about Teacher Appreciation Week next week, saying that it should be an entire month and encouraged Board members to please express their appreciation to any teachers they may know. The Stafford Education Foundation is hosting a recognition dinner on April 26, 2017, 6:00 p.m., at Mountain View High School. Dr. Benson spoke about five, \$2,000 scholarships that will be awarded as well as 18 innovative teaching grants.

A new mobile app will be available at the end of the month where parents can track their student's attendance, schedules, lunch purchase, bus routes, etc. The app is a part of the Schools' web content system with secure access.

The School Board is hosting a listening tour at Conway ES on May 15<sup>th</sup> from 6:00 to 7:30 p.m. Question and answers are welcome. Board members received an invitation to the Department of Student Services Gallery Opening, scheduled for May 31<sup>st</sup> from 4:00 to 6:00 p.m., at 31 Stafford Avenue, at the entrance is opposite School Board Chambers.

A new applicant tracking system is keeping track of the on-boarding process and will track new hires from application through a teacher's entire career with the Division. All graduations are scheduled for Saturday, June 17<sup>th</sup>. A roster of attendees was handed out. Also given to the Board were coffee mugs and pens with the new Stafford County Schools logo.

Ms. Sellers inquired about a program whereby donors could pay off student's lunch balances. Dr. Benson said that they did monitor that and staff was looking for a mechanism where those balances could be paid off. Ms. Sellers said she knows of someone looking to do that and asked Dr. Benson to contact her for info on the interested donor.

Ms. Bohmke thanked Dr. Benson, saying that the Board was pleased with each report that he gave; the Schools' continue to improve in so many areas, which was noticed by all members of the Board. Dr. Benson thanked Ms. Bohmke saying that he had a great team working with him.

Mr. Milde spoke about a 200 year old red oak tree at Stafford ES. Dr. Benson said that teachers were using that tree to weave historical stories into the curriculum. Mr. Milde said he attended a STEAM after school activity, which was when he learned about the tree.

#### Presentations by the Public –

Gary Scola with Newland Communities – update on Embrey Mill Road and Mine Road Phase II – it will be safe and passable in time for the new school year, fully paved and striped – meeting w/ VDOT this week to determine speed limit and begin process to have the road accepted into the State System of Secondary Roads. Mrs. Maurer thanked Mr. Scola; Mr. Milde said that Newland was a good community partner.

Bruce Jackson – Against extending "No Shooting Zones" saying that it gave neighbors a false sense of security; every shooter was responsible for every projectile whether bullet or arrow; attended NRA convention; purchased a shooting box that stops all types of ammunition.

# **Board Member Presentations** Board members spoke on topics as identified:

Ms. Bohmke - Attended the Comcast Day of Caring, worked on the landscaping at the Butler Road/Route 1 intersection; thanked the Sheriff's Office and Parks & Recreation staff for assisting; thanked Comcast where 100,000 volunteers worked on 900 country-wide projects. A routine training exercise for County Fire and Rescue personnel on the Rappahannock River led to the actual rescue and saving the lives of six people on the River. Provided an update on the Infrastructure Committee (IC) meeting; VDOT plans to hold several public venues to explain both the I-95 interchange project as well as the Courthouse Road/Route 1 intersection improvement project, which will take up to three years to complete.

Mr. Cavalier - Attended the Fredericksburg Regional Alliance (FRA) meeting; FRA is not renewing its consulting contract but is looking for off-base office space for MCBQ; Stafford County is in the best position and will work with the Base commander. He attended the Aquia Harbour Board of Directors meeting with Mr. Milde. The Widewater VFD, Station 3, has been remodeled with basic life support staffers 24/7 and the hopes to place advanced life support there in the near future, and provide 3 staffers, up from the 2 assigned there at present. Attended the QuIC Board of Directors meeting; there was a fire in the old building but no operations were

interrupted and no one was injured but the roof sustained substantial damage. Attended the Stafford Hospital Center's volunteer appreciation lunch where Mr. David Young was honored for having 4000 volunteer hours at Stafford Hospital Center, and 3000 hours at Mary Washington Hospital before the Stafford Hospital opened.

Attended the Civ-Mil Reception in Fauquier County where she had a good conversation with County Administrator, Tom Foley, and Base staff regarding base facilities in North Stafford. Thanked the Apple Grove HOA for inviting Mrs. Maurer to its HOA meeting and thanked staff for providing information that she was able to share with Apple Grove residents. Encouraged Eagle Scouts to apply for scholarships offered by the Armed Forces Communication and Education Association (AFCEA), the Quantico/Potomac Chapter. Scholarships are for high school seniors going into the field of Science, Technology, Engineering, or Math (STEM). Mrs. Maurer spoke about the incredible contributions made by Eagle Scouts in the County and looking forward to their future endeavors. She encouraged all Eagle Scouts to apply for the scholarships and said that Eagle Scouts John Asmus and Matthew Vickers were both recipients of a \$1000 scholarship.

Mr. Milde - Spoke about improvements on Route 1 north and south of the Courthouse Road interchange to include turn lanes, landscaping, widening and straightening the road, all of which is slated for completion within the next three years. The Armed Services Memorial is an \$838,000 project, construction has started; the County is buying a brick for every identified County resident that gave his or her life in the line of duty. Stafford County has been awarded the NACo National Achievement Award for open space planning including PDR and TDR and parcels placed in conservation easements. The program description is being distributed across the nation and Stafford County is considered a pioneer in open space planning.

Ms. Sellers - Attended a meeting of the Chaplin Office on Youth; working with them regarding private day school placements; Human Services Director, Donna Krauss, is also working on that initiative. An opiates forum will be held on May 5<sup>th</sup> at the Fick Center by Mary Washington Hospital; Ms. Sellers will sit on one of the panels at 8:00 a.m.; a movie "Chasing the Dragon" will be aired at 5:00 p.m. It is very visual, not recommended for young children. A portion of the documentary was filmed in this area.

Mr. Snellings - Clarified citizen's remarks made during public commentary regarding No Shooting Zones. Referring to Ms. Bohmke's comments about the Rappahannock River rescue, Mr. Snellings said that the Rappahannock is a very dangerous and unforgiving river with more than 100 drownings in the past 25 years.

Mr. Thomas - Attended VRE with Mr. Milde. Attended a VACo budget committee meeting in Richmond; happy to report that membership dues were remaining level and VACo will be getting more revenue from its marketing agreement. Update on the Community and Economic Development Committee (CEDC) meeting including a utilities rate

adjustment on unoccupied rental properties; a possible lifetime dog license (with more to come on that subject); changes to the Germanna Community College deed enhancing the State's comfort level on the bonds.

Report of the County Attorney – Mr. Shumate deferred his report.

Report of the County Administrator – Mr. Foley gave a presentation about accelerating economic development in the Courthouse area and discussed procurement of a redevelopment advisor to provide expertise to accelerate the redevelopment of the Courthouse RDA. A total planned investment is \$314.5 million to include recreation, tourism, government facilities, utilities, and transportation improvements. Mr. Foley noted that there is an opportunity to create "Downtown Stafford" or "Stafford Town Center" and to expand the County's commercial and overall business tax base. Redevelopment in the Courthouse area would be a catalyst for further commercial, retail, and other development in the larger targeted growth area and using public/ private partnerships to accelerate economic development opportunities in the area. redevelopment advisor would provide the expertise needed to accelerate economic growth and redevelopment in the Courthouse area. \$500,000 in one-time funding is available in the existing Stafford Opportunity Fund, and \$230,000 is available in on-going funding in the adopted budget, in ED strategic initiatives funding. Mr. Foley asked for (and received) Board concurrence regarding the proposed approach in procuring redevelopment advisory services and announced that a joint meeting between the Board and members of the Economic Development Authority was in the planning stages with a date and time to be determined.

Mr. Milde said that he agreed with the vision and timing and asked about a next step. Mr. Foley said that a Request for Proposal (RFP) would be prepared Mr. Cavalier said that he preferred using money from the second funding source as money in the Stafford Opportunity Fund was needed for other things.

A RESOLUTION AUTHORIZING THE COUNTY ADMINISTRATOR TO BUDGET AND APPROPRIATE FUNDS FOR SAFETY IMPROVEMENTS ON ROUTE 1 IN THE VICINITY OF TELEGRAPH ROAD AND WOODSTOCK LANE, AND TO REQUEST THE VIRGINIA DEPARTMENT OF TRANSPORTATION TO GIVE AUTHORITY TO THE COUNTY TO LOCALLY ADMINISTER THIS PROJECT

WHEREAS, the Board authorized staff to submit an application for state funding to complete safety improvements on Route 1 in the vicinity of Telegraph Road and Woodstock Lane (Project); and

WHEREAS, the Board committed up to \$1,275,000 in local funding towards this Project, using the remaining funds (\$1,107,953) provided from Widewater Area Transportation Impact Fees; and

WHEREAS, the Board desires that the Project be locally administered;

NOW, THEREFORE, BE IT RESOLVED by the Stafford County Board of Supervisors on this the 2nd day of May, 2017, that the County Administrator be and he hereby is authorized to budget and appropriate One Million One Hundred Seven Thousand, Nine Hundred Fifty-three Dollars (\$1,107,953) from Widewater Transportation Impact Fee Fund to the Transportation Fund for the design and construction of safety improvements on Route 1 in the vicinity of Telegraph Road and Woodstock Lane (Project); and

BE IT FURTHER RESOLVED that the Virginia Department of Transportation is requested to allow Stafford County to administer the Project as a locally administered project; and

BE IT STILL FURTHER RESOLVED the County Administrator is authorized to transmit this Resolution to the appropriate VDOT officials to effectuate this request, and to sign all documents that he deems necessary to effectuate this Resolution.

#### Resolution R17-130 reads as follows:

A RESOLUTION AUTHORIZING THE COUNTY ADMINISTRATOR TO EXCECUTE AN AGREEMENT WITH THE STAFFORD AREA SOCCER ASSOCIATION TO OPERATE THE COUNTY'S NEW ADULT RECREATIONAL SOCCER PROGRAM

WHEREAS, the Stafford Area Soccer Association (Stafford Soccer) currently operates a successful youth soccer program in the County; and

WHEREAS, Stafford Soccer has requested an agreement with the County to operate a new adult recreational soccer program; and

WHEREAS, at its meeting on April 13, 2017, the Parks and Recreation Commission recommended that the agreement between Stafford Soccer and the County be approved; and

WHEREAS, the Board has considered the recommendation of the Parks and Recreation Commission and staff, and has determined that it would be in the County's best interest to permit Stafford Soccer to operate the County's new adult recreational soccer program;

NOW, THEREFORE, BE IT RESOLVED by the Stafford County Board of Supervisors on this the 2nd day of May, 2017, that the County Administrator be and he hereby is authorized to execute an agreement with the Stafford Area Soccer Association to operate the County's new adult recreational soccer program for a period of five years, with an option to renew for five additional years.

AUTHORIZE THE COUNTY ADMINISTRATOR TO EXECUTE A CONTRACT WITH ATCS, P.L.C., FOR ENGINEERING SERVICES TO DESIGN THE BEREA CHURCH ROAD SAFETY IMPROVEMENT PROJECT; AND BUDGET AND APPROPRIATE FUNDS FROM THE WARRENTON ROAD SERVICE DISTRICT

WHEREAS, the Board identified the completion of road improvements on Berea Church Road (SR-654) (Project), as a critical part of Stafford County's road improvement plan; and

WHEREAS, staff advertised a request for proposals to provide the engineering services to design the Project; and

WHEREAS, staff evaluated the proposals received and determined that ATCS, P.L.C., was the most-qualified and submitted the most reasonable proposal for the scope of services sought; and

WHEREAS, the Virginia Department of Transportation (VDOT) reviewed and audited the proposal and also determined it to be acceptable and reasonable for the scope of work to be performed; and

WHEREAS, 50% of the cost of the Project would be reimbursed by VDOT as part of the revenue sharing program; and

WHEREAS, there are funds available in the Warrenton Road Service District Fund that can be used for the Project;

NOW, THEREFORE, BE IT RESOLVED by the Stafford County Board of Supervisors on this the 2nd day of May, 2017, that the County Administrator be and he hereby is authorized to execute a contract with ATCS, P.L.C., in an amount not to exceed Seven Hundred Seventynine Thousand Five Hundred Fifty-four Dollars (\$779,554), unless amended by a duly executed contract amendment; and

BE IT FURTHER RESOLVED that Three Hundred Eighty-nine Thousand Seven Hundred Seventy-seven Dollars (\$389,777) be budgeted and appropriated from the Warrenton Road Service District Fund, and Three Hundred Eighty-nine Thousand Seven Hundred Seventy-seven Dollars (\$389,777) to be reimbursed by the Virginia Department of Transportation

(VDOT) as part of the Revenue Sharing program be budgeted and appropriated to the Berea Church Road Safety Improvement Project Fund;

BE IT STILL FURTHER RESOLVED the County Administrator be and he hereby is authorized to sign all documents necessary for Stafford County to administer this project.

Item 12. Public Works; Authorize the County Administrator to Advertise a Public Hearing to Amend and Reordain County Code, Section 15.4(C), Maximum Speed in Residence Districts, Penalty on Estates Drive

#### Resolution R17-134 reads as follows:

A RESOLUTION AUTHORIZING THE COUNTY ADMINISTRATOR TO ADVERTISE A PUBLIC HEARING TO AMEND AND REORDAIN STAFFORD COUNTY CODE SEC. 15- 4.1(C), "MAXIMUM SPEED LIMITS IN CERTAIN RESIDENCE DISTRICTS; PENALTY"

WHEREAS, Virginia Code § 46.2-878.2 authorizes a \$200 fine for persons exceeding the maximum speed limit in designated residence districts; and

WHEREAS, on May 6, 1997, the Board adopted Ordinance O97-29(R), which approved criteria for the establishment of residence districts where an additional fine could be levied; and

WHEREAS, the County received a petition from residents of the Estates of Hartwood subdivision to establish a residence district within that subdivision; and

WHEREAS, County staff conducted a traffic study and determined that Estates Drive, in the Estates of Hartwood subdivision, met the criteria to establish a residence district; and

WHEREAS, the Board desires to consider designating Estates Drive as a residence district;

NOW, THEREFORE, BE IT RESOLVED by the Stafford County Board of Supervisors on this the 2nd day of May, 2017, that the County Administrator be and he hereby is authorized to advertise a public hearing to consider amending Stafford County Code Sec. 15-4.1(c), by designating Estates Drive (SR-2344) from Hartwood Road (SR-612) to the ending cul-de-sac of Estates Drive as a residence district.

Item 13. Public Works/Utilities; Authorize the County Administrator to Approve Two Change Orders to the Garrisonville Road Widening Project; Execute a Memorandum of Agreement with The Pence Group for Payment of the Change Order; and Budget and Appropriate Funds from The Pence Group

#### Resolution R17-135 reads as follows:

AUTHORIZE THE COUNTY ADMINISTRATOR TO EXECUTE A CHANGE ORDER FOR THE GARRISONVILLE ROAD WIDENING PROJECT; EXECUTE A MEMORANDUM OF AGREEMENT (MOA) WITH ROUTE 606-RESTON, LLC AND STAFFORD 12ACRES LLC FOR PAYMENT OF THE CHANGE ORDER; AND BUDGET AND APPROPRIATE FUNDS RECEIVED PURSUANT TO THE MOA

WHEREAS, the Board identified the completion of road improvements on Garrisonville Road (SR-610), as a critical part of Stafford County's road improvement plan; and

WHEREAS, Route 606-Reston, LLC, is the owner of Tax Map Parcel No. 20-130, and Stafford 12Acres, LLC, is the owner of Tax Map Parcel No. 20-127, and are hereinafter referred to collectively as the Pence Group; and

WHEREAS, staff worked with the Pence Group to incorporate the necessary roadway improvements associated with its planned development, The Garrison at Stafford, as part of the Garrisonville Road Widening Project; and

WHEREAS, Branch Civil, Inc., the contractor currently constructing the Garrisonville Road Widening Project, developed a change order based on the additional roadway improvements associated with The Garrison at Stafford; and

BE IT FURTHER RESOLVED that the County Administrator is authorized to execute a Memorandum of Agreement with Route 606-Reston, LLC, and Stafford 12Acres, LLC, (the Pence Group) outlining the terms and conditions for the payment of the change order for the incorporation of the roadway improvements for The Garrison at Stafford as part of the Garrisonville Road Widening Project; and

BE IT STILL FURTHER RESOLVED that the County Administrator is authorized to budget and appropriate Two Million One Hundred Fifty-four Thousand Two Hundred Thirty-three dollars (\$2,154,233) received from the Pence Group to the Transportation Fund for the Garrisonville Road Widening Project.

#### UNFINISHED BUSINESS

Item 17. Planning and Zoning; Consider the Creation of a New Overlay District Entitle Integrated Corporate and Technology Park (ICTP) Director of Planning and Zoning, Mr. Jeff Harvey, gave a presentation and answered Board members questions. Mr. Harvey detailed permitted by-right uses in the B-2 Zoning District, which included a convention facility, light manufacturing, and multi-family dwellings; and by special exception, an adult day care facility. In the M-1 Zoning District, permitted by-right uses include a bank/lending institution, a child care center, medical or dental clinic, a convention facility, drug store, low intensity commercial retail (with a CUP), medium intensity commercial retail (also with a CUP), multi-family dwellings, a school, professional office, a hospital (with a CUP), and with special exceptions, a microbrewery and/or adult day care facility. Mr. Harvey stressed that there were no pending applications for the proposed ICTP, and the only two possible locations in the County (at present) was the Quantico Corporate Center (QCC) or Riverside Business Park.

Mr. Milde inquired if it would be an overlay on an existing zoning district, to which Mr. Harvey agreed, saying it would be similar to the Highway Corridor Overlay District (HCOD), the Chesapeake Bay Act, and the Flood Hazard Zone. Any applications would be reviewed by both the Planning Commission and the Board before approval (or denial) of the request. Ms. Sellers asked about requiring a conditional use permit (CUP) for multi-family housing. Mr. Harvey said that was feasible, and it would be more restrictive.

Ms. Bohmke asked about the 24 units/acre. Mr. Harvey said there were no others with that density and building height was not quite as high as the 80' permitted in the proposed ICTP, for three to four story buildings. Ms. Bohmke asked how off-site school proffers would be handled and what was the proffer date used. Mr. Harvey said that the trigger date was when the proffers were calculated and that state proffer guidelines prohibited designating proffers to schools that were not at enrollment capacity.

Mr. Harvey asked County Attorney, Mr. Charles Shumate, if the Board could go below the 24 units/acre. Mr. Shumate said that the Board could go below; the proposal was flexible as to density on the property.

Mr. Cavalier motioned, seconded by Ms. Maurer, to defer a vote on ICTP, stating that the sense of urgency at QCC has dissipated.

Mrs. Maurer had questions about the original send-down to the Planning Commission and its returned proposal to the Board. Ms. Rysheda McClendon, Deputy County Attorney, said that the Planning Commission held two public hearings, one was consideration of the ICTP including the multi-family housing component, and the second public hearing was consideration of the ICTP without the multi-family housing component.

Ms. Bohmke asked if Riverside and/or QCC applied, would the roads within the development be state maintained. Mr. Harvey said that main road into the QCC was considered private but the main road into Riverside was a public road and was state maintained. She asked if school buses would be permitted into QCC and Riverside. Mr. Harvey said that would depend on the policy of the School Board; that Aquia Harbour roads were private and school buses picked up students in there.

Mr. Snellings said that he was going to support deferral; he could not support more by-right development and felt that the Board needed more control. Ms. Sellers agreed with Mr. Snellings saying that it should be sent back to the Planning Commission without the residential component.

Mr. Milde asked if there were an application submitted, would Board approval be required. Mr. Harvey said that it would as with all rezoning applications.

Following additional discussion, Ms. Sellers motioned, seconded by Mr. Milde, to adopt proposed Ordinance O17-03, including the requirement of a CUP for rezoning.

Mr. Thomas said that the Planning Commission suggested removal of the multi-family component. Mrs. Maurer said that she seconded Mr. Cavalier's motion for deferral but with the inclusion of the CUP requirement, she would be in favor the proposed ordinance, adding that with more than 400,000 square feet of office space, and more than 4,000 people working in that space, there was a significant, and positive transportation impact if even a portion of those people

lived, worked, and played in the vicinity of their employment. Mr. Cavalier said he was befuddled; that he originally motioned for deferral because he did not think there was support for ICTP to pass, but that he supported it from the "get-go." He withdrew his motion.

Mr. Milde said again that there were no applications before the Board, no by-right developments; that voting for the ICTP was simply to adopt the Overlay District. Interested developers would have to submit an application, and if Ms. Sellers' motion passed, a CUP would have to be submitted to include multi-family housing. The Planning Commission and the Board would then review and consider staff's recommendation before voting to approve or deny the application. He said that it was a concept that was before the Board at that time. Mr. Snellings said that concepts turned into apartments.

Mr. Thomas said there was no applicant in front of the Board at this time; that he was against the multi-family component from the beginning but he met with a developer interested in building very high-end units. He said with the new proffer legislation, nothing could be done with proffer money, and there was no way to guarantee that the multi-family housing component would be filled with urban professionals, not families with children. Ms. Sellers said that while proffer laws changed, proffers were not "out the window," and she disagreed with Mr. Thomas. Mr. Milde said that he was not in favor of rezoning or apartments either but that this was not a vote for apartments or a specific rezoning. Mr. Milde called the question.

WHEREAS, the M-1 Zoning District does not permit the variety of uses that support corporate and technology parks, such as child care centers, clinics, commercial retail, convention facilities, hotels, and employee housing; and

WHEREAS, the Board desires to create an Integrated Corporate and Technology Park Overlay Zoning District to allow for a variety of uses for specific areas of the County where corporate and technology parks exist; and

WHEREAS, the Board carefully considered the recommendations of the Planning Commission and staff, and public testimony, if any, received at the public hearing; and

WHEREAS, the Board finds that public necessity, convenience, general welfare, and good zoning practice require adoption of such an Ordinance;

NOW, THEREFORE, BE IT ORDAINED by the Stafford County Board of Supervisors on this the 2<sup>nd</sup> day of May, 2017, that Stafford County Code Sec. 28-33, "Districts generally;" Sec. 28-34, "Purpose of districts;" Sec. 28-35, "Table of uses and standards;" Sec. 28-39, "Special regulations;" and Sec. 28-102, "Off-street parking;" be and they hereby are amended and reordained as follows, with all other provisions remaining unchanged:

# Sec. 28-33. – Districts generally.

# Sec. 28-34. - Purpose of districts.

In order to carry out and implement the purposes and objectives of this chapter, the land use districts herein established shall have the following purposes, respectively:

The purpose of the ICTP district is to promote the integration of uses to facilitate the growth and development of large scale corporate office and technology parks. Such parks have the need for and shall include integrated uses such as Class A office space, hotel space for corporate clientele, supporting retail services, data centers, child care, and multi-family housing for employees working in the district and nearby area. Such districts shall be designed to accommodate at least 400,000 square feet of existing corporate office space for services such as engineering, security, computer systems development, computer software development, education, and research and development.

# Sec. 28-35. – Table of uses and standards.

Table 3.1, District Uses and Standards, sets forth the uses and standards for each zoning district in Stafford County. No land or structure shall be used, occupied or developed except in accordance with the standards set forth therein.

- (y) Special provisions applicable to ICTP Overlay Districts.
  - (1) Sidewalks shall be provided connecting buildings, streets, alleys and common areas.
  - (2) All buildings shall have integrated architectural designs that utilize common themes and building materials throughout the district, and comply with the Neighborhood Design Standards element of the Comprehensive Plan.
  - (3) No more than ten (10) percent of the dwelling units in a multi-family building can have three (3) or more bedrooms.

Item 18. Discuss No Shooting Zones (Gary Snellings) Mr. Snellings requested that this item be included on the next Public Safety Committee meeting agenda for further discussion. Mr. Thomas asked, if the ordinance was changed, could it be changed back if there were changes to the areas in which the No Shooting Zones were located. Ms. McClendon responded that the Board could hold a public hearing and revise the Ordinance. Mr. Thomas said that most of the problem calls that he received were noise complaints, but that safety was an issue to keep in mind as well. Mr. Snellings said that the call he received was from the neighbor of a person who shot 400 rounds from a high powered rifle, across two other properties and into Lake Abel. Mr. Snellings said he was concerned if a bullet missed the berm that the shooter created, someone could be seriously injured or killed. Ms. Maurer asked that the draft include the ability for neighborhoods to be removed from the No Shooting Zone. Ms. Sellers asked about boundaries or subdivisions included in No Shooting Zones. Ms. McClendon said that it had to do with property boundaries, not necessarily defined neighborhoods.

Ms. Maurer motioned, seconded by Ms. Bohmke, to send this item to the Public Safety Committee.

Item 19. Discuss Amending the Board's Bylaws (Section 3-1) to Change the Order of the Agenda Mr. Foley suggested that the Board's Bylaws Committee give consideration to changing the order of the meeting agenda so that a vote on the final agenda (including additions and deletions) took place at the beginning of the meeting, immediately following the Roll Call and Call to Order. That would enable staff and citizens to know exactly what the Board would hear and possibly vote on without having to wait until after presentations by the Board, the public, and any special presentations scheduled on any given agenda.
